Foreclosures

SITUATION: A FAMILY/INDIVIDUAL IS UNSURE OF THE MEANING OF FORECLOSURE

Foreclosure is a legal process in which a lender attempts to recover the balance of a loan from a borrower who has stopped making payments to the lender by forcing the sale of the asset (usually the home) used as the collateral for the loan.

SITUATION: AN INDIVIDUAL/FAMILY OWNERS IF THEY ARE IN FORECLOSURE

If you receive a foreclosure notice in the mail, it means you've fallen far enough behind in your mortgage payments that your lender intends to take your property and sell it off unless you make up the late payments.

SITUATION: AN INDIVIDUAL/FAMILY NEEDS FORECLOURE PREVENTION ASSISTANCE

Don't delay seeking help! The homeowner is given a limited period of time where they have a chance to cure the default and pay all amounts due, including interest, penalties, attorney charges and any other fees allowed by the law or the mortgage. Contact your mortgage lender as soon as you know you will be unable to make your mortgage payments. Let them know of your circumstances.

The Homeownership Center of Charlotte

advises homeowners who are facing foreclosure by providing individual advising sessions to assist them with curing their mortgage default. We serve Mecklenburg, Cabarrus, Gaston, Iredell, Lincoln, and Union counties in North Carolina. The first step is to make an appointment with a Homeownership Advisor who will let you know what documents you need to gather. SITUATION: AN INDIVIDUAL/FAMILY NEEDS HELP PAYING THEIR MORTGAGE

Contact your lender: Find out the exact details of what the lender believes you did or did not do. Ask the lender what you can do to remedy the default. Some lenders will work with you, so it doesn't hurt to ask.

The NC Foreclosure Prevention Fund[™] makes mortgage payments for unemployed workers while they seek jobs or complete job training in a new field. Homeowners do not need to be behind on payments to seek help. Provides CWC-Secured loan to high-risk clients for up to \$750 with direct paycheck drafting and a maximum six-month term at 3.15% APR.
